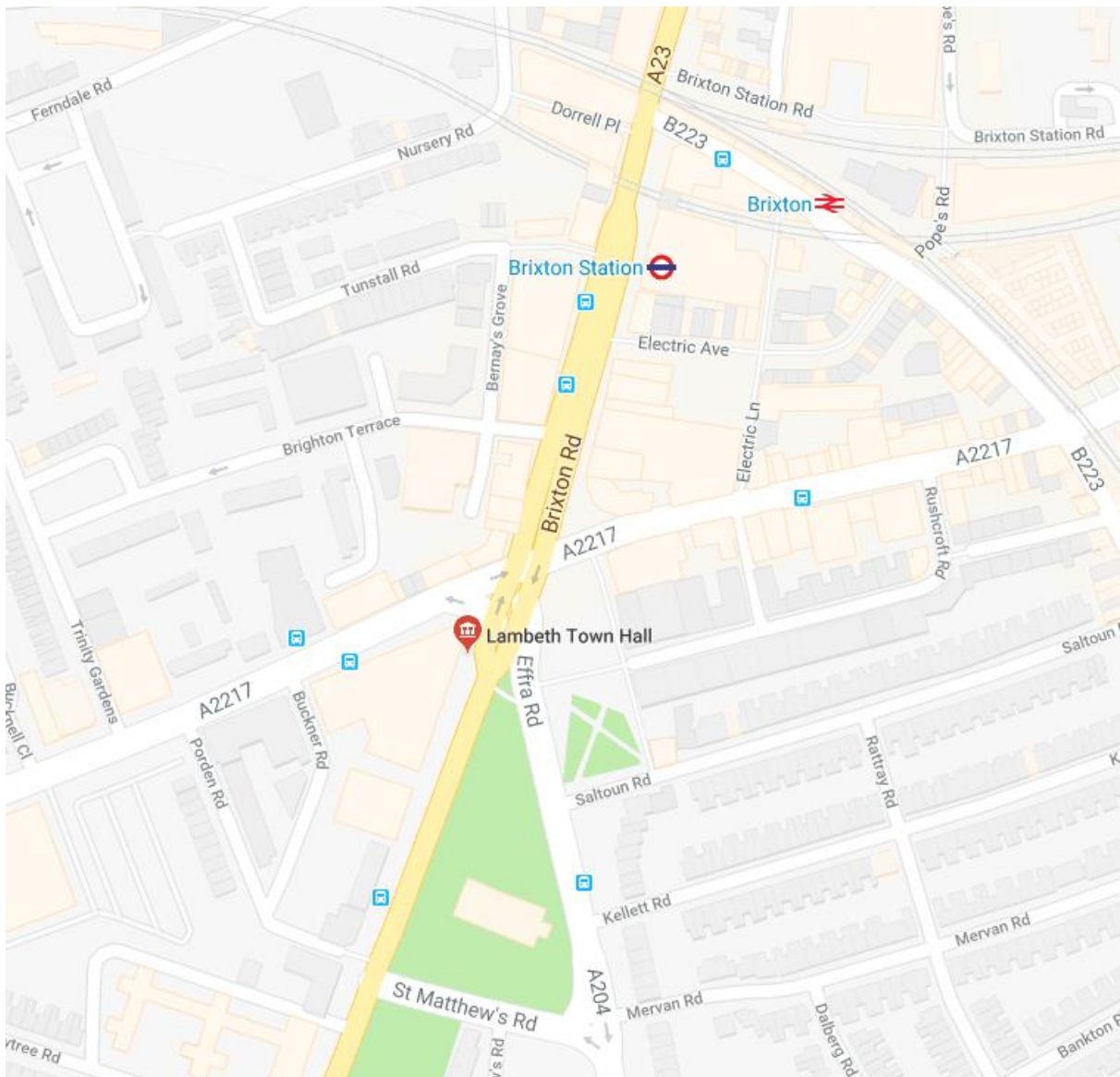
Security
