Patrons permitted to temporarily leave and then re-enter the premises to smoke shall be restricted to a designated smoking area at the front of the premises

b) The prevention of crime and disorder

A doorman will be hired on a fri or sat night from 10pm if basement is being used to make sure conditions are being met.

c) Public safety

A direct telephone number for the Licence Holder/DPS/ manager of the premises shall be publicly available at all times that the premises is open. The number is to be made available to residents and businesses in the vicinity. Any complaints shall be remedied within 48 hours and details to be recorded in the incident book including the action taken by the Licence Holder/DPS/manager

d) The prevention of public nuisance

Notices shall be prominently displayed at any area used for smoking requesting patrons to respect the needs of local residents and use the area quietly. Anyone drinking outside will be told to come in at 1030pm All double glazed windows to be closed at 1030pm to keep noise down Patrons temporarily permitted to leave and re-enter the premises e.g. to smoke, shall not be permitted to take drinks with them after 1030pm.

e) The protection of children from harm

All children under the age of 18 shall be accompanied by a responsible adult at all times whilst on the premises after 19:00
