The premises shall install and maintain a comprehensive CCTV system. All entry and exit points must be covered enabling frontal identification of every person entering in a light condition. The CCTV system shall continually record whilst the premises are open. All recordings shall be stored for a minimum period of 31 days with date and time stamping.

b) The prevention of crime and disorder

An incident log shall be kept at the premises and made available on request to an authorised officer of the Lambeth Council or the Police. any complaints received concerning crime and disorder any incidents of disorder any refusal of the sale of alcohol including date, time and name of staff member

c) Public safety

The premises shall not sell ales, beer, lager or cider or similar above 6% ABV (Alcohol by Volume). Any cans or bottles of ales, beers, lagers, cider or similar will be sold in a minimum of 4. There will be no sale of white cider in bottles larger than 750ml at the premises. The premises shall not sell or supply miniature bottles of spirits of 50ml or less.

d) The prevention of public nuisance

Signage shall be displayed at the exit of the premises requesting customers leaving the premises to do so quietly so as not to disturb nearby residents

e) The protection of children from harm

The premises shall operate a proof of age scheme (minimum Challenge 25). Under such scheme the only forms of acceptable identification will be photographic identification cards such as driving licenses, passports or proof of age cards bearing the "PASS" mark hologram.
