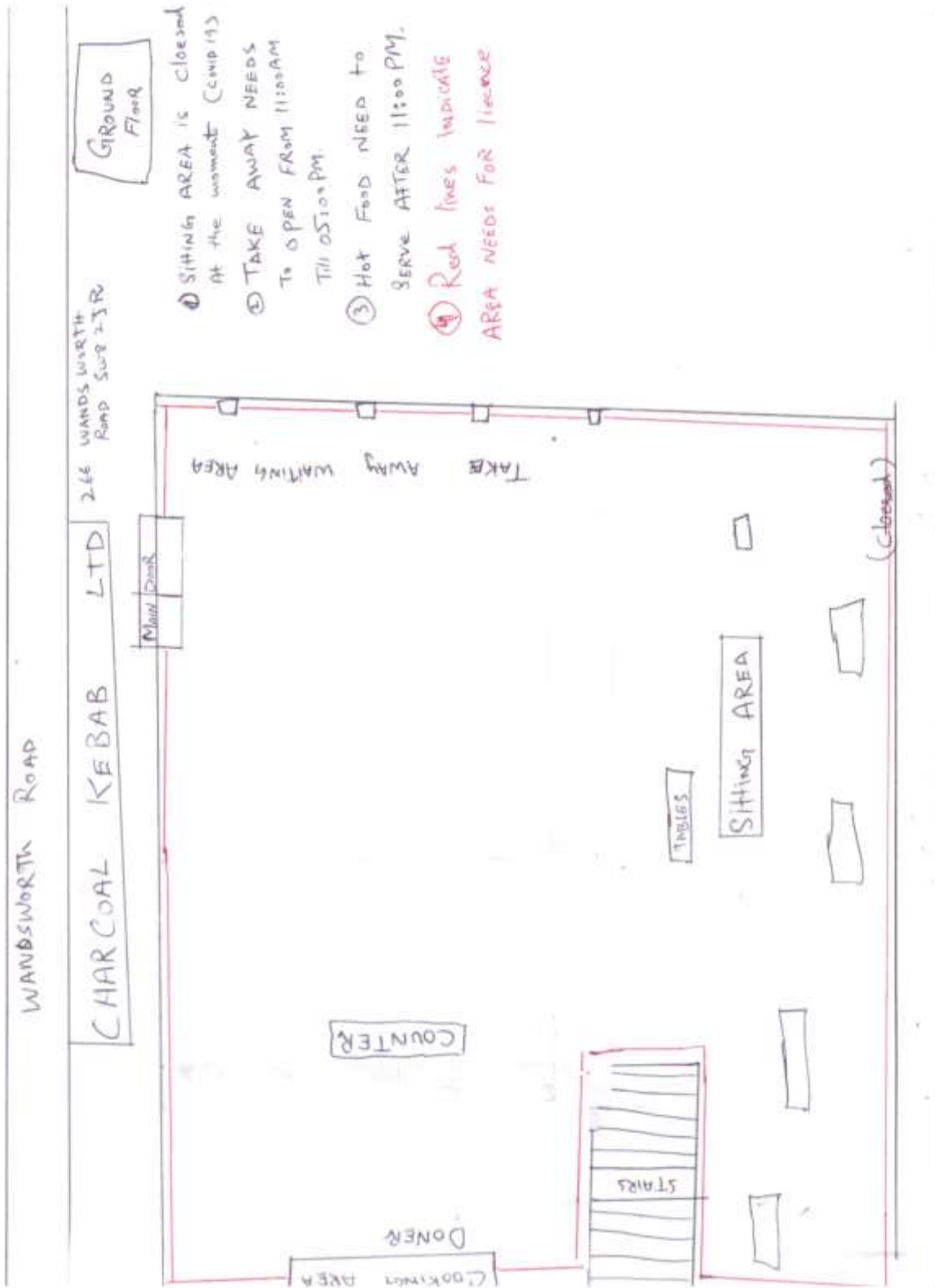
Annex 2 – Conditions consistent with the Operating Schedule

1. The premises shall operate as a delivery service after 00:00 and customers shall not be permitted inside the premises after this time.
2. Vehicles used for delivery should not be left idle outside the premises to ensure residents in the locality are not disturbed
3. All waste shall be properly presented and placed out for collection no earlier than 30 minutes before the scheduled collection times
4. No noise generated on the premises, or by its associated plant or equipment, shall emanate from the premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance
5. The Premises Licence Holder shall ensure that clearly legible notices shall be displayed at all exits from the premises requesting patrons to respect the needs of local residents and to leave the premises and area quietly
6. An incident log shall be kept at the premises, and made available on request to an authorised officer of the Lambeth Council or the Police. It must be completed within 24 hours of the incident and will record the following:
 - a) all crimes reported to the venue
 - b) all ejections of patrons
 - c) any complaints received concerning crime and disorder
 - d) any incidents of disorder
 - e) any visit by a relevant authority or emergency service.
7. A direct telephone number for the manager of the premises shall be publicly available at all times that the premises is open. This number is to be made available to residents and businesses in the vicinity. Any complaints shall be remedied within 48 hours and details to be recorded in the incident book including the action taken by the manager.
