Thanks for your email.

I appreciate the compromises you are prepared to make but I would also respectfully request you reconsider your proposal for door supervisors on Sundays. From looking at the crime statistics contained in your representation the majority of the offences in 2019 took place on Friday and Saturday nights when we are happy to accept door staff to be on duty (53% of all the violence and weapon offences took place within Friday and Saturday NTE; 66% of drug offences were recorded to take place on Friday and Saturday NTE; and 37% of all theft and robbery offences in Clapham CIZ happen in 5 hours between 23:00 on Friday night and 04:00 on Saturday morning).

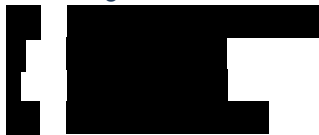
Our application is not proposing an increase in hours of alcohol as your representation suggests. My client is spending £1.2 million on the premises and wants to work with the authorities to create a safe and enjoyable environment as they have done in other London boroughs. If you are willing to reconsider your request for door supervisors on Sundays I can then take our client's instructions on your other conditions with a view to having these all agreed.

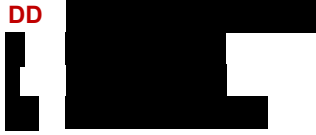
